The submission should be electronic and mailed to: <u>s.kampa@samarytanin.opole.pl</u> with the deadline 30.05.2018 time 15:00 in accordance with the form which is the annex 1 to Information of the technical dialogue.

The Contracting Entity requires the attachment of the following information and documents:

- 1) the dialogue participant data,
- 2) the document which certificates the legal status of the provider,
- 3) the document which indicates a person entitled to represent the provider,
- 4) the power of attorney which authorizes a representation of the provider (if the representation data are not demonstrated in the document indicated in sections 2 or 3),
- 5) the declaration of acquainting with the Rules of performing the technical dialogue.

During the technical dialogue meeting the providers will make a presentation of the medical equipment which is the subject of the technical dialogue (the technical descriptions in paper or send by e-mail, the catalogues, the prospects). There will be discussed the technical issues, technological issues, legal issues, the organization and economic issues which are related to the technical dialogue subject.

The participants in the technical dialogue will not obtain any remuneration or any reimbursement of the costs related to the preparation and participation in the technical dialogue. Not joining the technical dialogue will not limit the rights or it will not count against the proposed providers during the procedure.
